Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. #### 8.2 Exposure controls

**Appropriate engineering** controls

: Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
