### 4.1 Description of first aid measures

**Eye contact**

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. ## **SECTION 6: Accidental release measures**
