Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. In case of inhalation of decomposition products in a fire, symptoms may be delayed. Skin contact

6.2 Environmental precautions

Small spill

8.2 Exposure controls

Appropriate engineering controls

: Provide enhanced general ventilation by mechanical means. Use in room with a volume of minimum 100 m³.

Individual protection measures

Hygiene measures
