This classification report defines the classification assigned to the product family "TEKNOSAFE FLAME GUARD 2457-10" in accordance with the procedure given in EN 13501-1:2018.

This report replaces RISE report O100352-147289-15, dated March 2, 2022. This revision includes new test data as well as a change of classification.

2 Details of classified product

2.1 General

The products in "TEKNOSAFE FLAME GUARD 2457-10" family are fire retardant surface coated construction products. Their classification is valid for the following end use applications:

Wall cladding and wall panel.

According to the owner of this classification report, this product family complies with the European product specification EN 13986:2004+A1:2015 and EN 14915:2013+A2:2020.

2.2 Product description

The product family, "TEKNOSAFE FLAME GUARD 2457-10" (as described by the sponsor), is fully described below or is fully described in the test reports provided in support of classification listed in Clause 3.1.

According to information provided by the client, the product has the following composition:

System 1:

Paint system called, "P1a-A-CS", consisting of a water-borne intumescent primer called "TEKNOSAFE FLAME GUARD 2457-10", nominal applied amount 250 g/m² (wet weight).

Paint system called: "P1b-AB-CS" consisting of water-borne intumescent primer called "TEKNOSAFE FLAME GUARD 2457-10", nominal amount 250 g/m² (wet weight). Top coat called "TEKNOSAFE FLAME PROTECT 2458-00" nominal applied amount 100 g/m² (wet weight).

Both systems are applied by spray application.
