Reaction to fire classification report

1 Introduction

This classification report defines the classification assigned to the product "Forestia Chipboard + Teknosafe 2457" in accordance with the procedure given in EN 13501-1:2007+A1:2009.

2 Details of classified product

2.1 General

The product "Forestia Chipboard + Teknosafe 2457" is defined as a coated wooden particle board system. Its classification is valid for the following end use applications:

According to the owner of this classification report, this product complies with the European product specification EN 13986.

2.2 Product description

The product, "Forestia Chipboard + Teknosafe 2457", is fully described below:

Coated wooden fibre board system, consisting of a core of "Forestia Chipboard", nominal thickness 12 mm and nominal density 700 kg/m^3 . The facing of the product is coated with a FR-paint called "Teknosafe 2457", nominal area weight of $250 - 300 \text{ g/m}^2$ (wet weight).

4.3 Field of application:

This classification is valid for the following product parameters:

Wooden fibre board "Forestia Chipboard".

Nominal thickness: 12 mm.

Nominal density: 700 kg/m³.

Paint system consisting of the following layers, applied on the wooden fibre board.

Coating (Teknosafe 2457): nominal amount, 250 – 300 g/m² (wet weight).

Maximum organic content in coating specified as TOP-NCS-S0540Y20R / AV - 57.3 ml / 0.9 liter.



This classification is valid for the following end use conditions:

Substrates

• Wood based substrates at least 10 mm thick and any end use substrate of Euroclasses A1 or A2-s1,d0 at least 9 mm thick, having a density $\geq 510 \text{ kg/m}^3$.

Fixings

- Joints glued with PVAc adhesive.
- Mechanically fixed.

Joints

Horizontal and vertical joints.
